*All rates apply to the charter with a 4 passenger limit. We are licensed for 6 so if you have additional people please contact us.

Cancellations must be made by mail, phone, or email no less than 7 days prior to the charter date. A full refund will be made under these conditions only. Cancellations caused by inclement weather, rough water, storm warnings, mechanical defect or any other conditions beyond the control of the captain will be rebooked on a future date agreeable to the charter party and the captain. The captain makes the final determination concerning the vessel's departure. If rescheduling cannot be done due to time or other constraints any deposit will be refunded.

The Captain may cancel any charter without refund for any of the following reasons: Any member of the charter is intoxicated, under the influence of drugs, possessing any illegal drugs, acts in an unruly manner, poses a threat to safe operation of the vessel, or obstructs the Captain and/or crew from their normal duties.

We do not require a deposit to keep things simple. Should you cancel your trip within 7 days, you will agree to send a \$200 payment for late cancellation. Because of the investment in bait and supplies, if you cancel your trip within 24 hours you will be expected to pay 50% of the agreed upon fee.

Fishing Provisions and Overview

Catch and release of all unwanted fish is strongly recommended and all Marlin are released, otherwise all fish caught are the property of the charter customer. We do not offer a fish cleaning service however there are several in town. If your trip includes a mate, the mate may elect to provide this service. All Federal and State catch regulations will be enforced. Sterling II will provide all the necessary tackle, bait, and ice.
